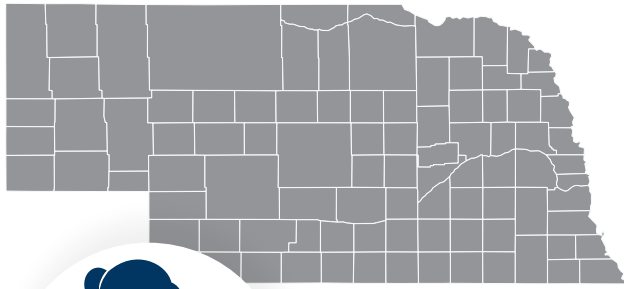

The abortion industry is circulating a ballot initiative seeking to create a right to abortion in the Nebraska Constitution, which would legalize abortion until birth. Abortion advocacy groups are currently collecting signatures and spending millions of dollars to confuse and mislead voters.

WHAT'S IN THE INITIATIVE?

Broad Exceptions

The initiative contains a vague “health exception” determined entirely by the abortionist. **Exceptions could include non-physical factors, such as emotional, spiritual, and financial health.** This opens the door to abortions up until birth.

Late-Term Abortions

Viability is defined as being based solely on the abortionist’s judgment and would allow abortions in the second and third trimesters. Babies feel pain before viability—at 15 weeks or earlier. **Babies who can experience pain would be subjected to painful late-term abortions.**

No Parental Consent

The initiative creates a fundamental right to abortion for “all persons,” including children and minors. This would eliminate our state’s parental consent law, meaning **parents will not have any ability to consent or even know if their child seeks or obtains an abortion.**

Protections Eliminated

A “fundamental right to abortion without interference from the state” puts **existing medical safeguards that protect the health and safety of women at risk of being eliminated.** This includes informed consent statutes and requirements that the abortion be performed in person and by a licensed doctor.

NEBRASKA IS A PRO-LIFE STATE

1973

THE ROE V. WADE DECISION

Wrongly created a right to abortion and invalidated protections for the unborn in state constitutions.

Nebraska is a pro-life state. For decades, Nebraska Family Alliance has worked alongside pro-life lawmakers to enact life-affirming statutes for the unborn and protect the health and safety of women in Nebraska.

1991

PARENTAL NOTIFICATION

Requires parental notification for minors to obtain an abortion.

1993

INFORMED CONSENT

Requires abortionists to inform women seeking an abortion about the associated risks.

1997

PARTIAL BIRTH ABORTION

Prohibits a late-term abortion method that partially delivers the unborn child.

2002

ASSAULT ON AN UNBORN CHILD ACT

Creates a criminal penalty for injuring an unborn child during an assault on a pregnant woman.

2004

HOMICIDE OF UNBORN CHILD ACT

Creates criminal penalties for the intentional and unintentional death of an unborn child.

2009

MOTHERS' RIGHT TO SEE ULTRASOUND

Requires abortionists to give mothers a chance to view the ultrasound before an abortion procedure.

2010

PAIN-CAPABLE UNBORN CHILD PROTECTION ACT

First state in the nation to prohibit abortion after 22 weeks gestation.

2011

WEBCAM ABORTIONS

Prohibits the prescription of abortion pills remotely or over a webcam.

PARENTAL CONSENT

Requires parental consent for minors to obtain an abortion.

2017

CHOOSE LIFE LICENSE PLATES

Promotes a culture of life, and proceeds support families in need.

COMPASSION AND CARE FOR MEDICALLY CHALLENGING PREGNANCIES

Informs parents of perinatal hospice for unborn children diagnosed with terminal conditions.

2018

END TAXPAYER FUNDING FOR ABORTION

Strips abortion providers and agencies who refer abortions of Title X taxpayer dollars.

COMMEMORATIVE BIRTH CERTIFICATES FOR MISCARRIED CHILDREN

First state in the nation to offer commemorative birth certificates for babies lost through miscarriage.

2019

ABORTION PILL REVERSAL INFORMATION ACT

Provides women seeking a medication abortion information about abortion reversal.

2020

DISMEMBERMENT ABORTIONS

Prohibits dismemberment abortions on living, preborn babies.

2023

PREBORN CHILD PROTECTION ACT

Prohibits abortion after 12 weeks gestation with exceptions for rape, incest, and the life of the mother.

2024

WHAT'S NEXT FOR NEBRASKA?

NFA's vision is to see Nebraska become a place where every life is cherished and protected. **However, Nebraska's pro-life laws could be at risk if the pro-abortion ballot initiative is successful.**
