



## A THREAT TO WOMEN IN NEBRASKA INITIATIVE 439

The abortion industry is attempting to enshrine a right to abortion in the Nebraska Constitution with Initiative Measure 439 that would legalize late-term dismemberment abortions, eliminate health and safety standards, remove parental notification requirements, put girls at greater risk for human trafficking, and pave the way for taxpayer-funded abortion.

### WHAT'S IN PRO-ABORTION INITIATIVE MEASURE 439?

*“All persons shall have a fundamental right to abortion until fetal viability, or when needed to protect the life or health of the pregnant patient, without interference from the state or its political subdivisions. Fetal viability means the point in pregnancy when, in the professional judgment of the patient’s treating health care practitioner, there is a significant likelihood of the fetus’ sustained survival outside the uterus without the application of extraordinary medical measures.”*

#### Jeopardizes Women’s Health & Safety

Allows abortionists and individuals who are not licensed physicians to influence the medical decisions of a woman in crisis.

#### Abortion Against Her Will

Creates a right to abortion for “all persons,” which allows men to force a woman into an abortion against her will.

#### Taxpayer-Funded

Paves the way for taxpayer funding of elective abortions in Nebraska, even against strongly held moral and religious objections.

#### Human Trafficking

Overturns parental notification laws, which allows predators and human traffickers to continue their abuse in the shadows.

## THE ROE V. WADE DECISION

Wrongly created a right to abortion and invalidated protections for the unborn in state constitutions.

Nebraska is a pro-life state. For decades, Nebraska Family Alliance has worked alongside pro-life lawmakers to enact life-affirming statutes for the unborn and protect the health and safety of women in Nebraska.

1991

## PARENTAL NOTIFICATION

Requires parental notification for minors to obtain an abortion.

1993

## INFORMED CONSENT

Requires abortionists to inform women seeking an abortion about the associated risks.

1997

## PARTIAL BIRTH ABORTION

Prohibits a late-term abortion method that partially delivers the unborn child.

2002

## ASSAULT ON AN UNBORN CHILD ACT

Creates a criminal penalty for injuring an unborn child during an assault on a pregnant woman.

2004

## HOMICIDE OF UNBORN CHILD ACT

Creates criminal penalties for the intentional and unintentional death of an unborn child.

2009

## MOTHERS' RIGHT TO SEE ULTRASOUND

Requires abortionists to give mothers a chance to view the ultrasound before an abortion procedure.

2010

## PAIN-CAPABLE UNBORN CHILD PROTECTION ACT

First state in the nation to prohibit abortion after 22 weeks gestation.

2011

## WEBCAM ABORTIONS

Prohibits the prescription of abortion pills remotely or over a webcam.

## PARENTAL CONSENT

Requires parental consent for minors to obtain an abortion.

2017

## CHOOSE LIFE LICENSE PLATES

Promotes a culture of life, and proceeds support families in need.

## COMPASSION AND CARE FOR MEDICALLY CHALLENGING PREGNANCIES

Informs parents of perinatal hospice for unborn children diagnosed with terminal conditions.

2018

## END TAXPAYER FUNDING FOR ABORTION

Strips abortion providers and agencies who refer abortions of Title X taxpayer dollars.

## COMMEMORATIVE BIRTH CERTIFICATES FOR MISCARRIED CHILDREN

First state in the nation to offer commemorative birth certificates for babies lost through miscarriage.

2019

## ABORTION PILL REVERSAL INFORMATION ACT

Provides women seeking a medication abortion information about abortion reversal.

2020

## DISMEMBERMENT ABORTIONS

Prohibits dismemberment abortions on living, preborn babies.

2023

## PREBORN CHILD PROTECTION ACT

Prohibits abortion after 12 weeks gestation with exceptions for rape, incest, and the life of the mother.

2024

## WHAT'S NEXT FOR NEBRASKA?

Nebraska's pro-life protections will be eliminated if Initiative Measure 439 is successful.

Our state is at a crossroads, and on Election Day, Nebraska voters must reject Initiative 439.
